## 1 About the Events team

- 1.1 The Events team is an internal service which for 2024/25 sat within the Council's Resident and Enabling Services directorate, forming part of the Highways, Environment and Facilities Management Division, responsible for facilitating outdoor events that take place in Lambeth's parks and open spaces and on the public highway. We work closely with our colleagues in Parks, Highways, Parking, Culture and Community Safety. Our aim is simple: to facilitate, enable and permit culturally diverse private and public events across the whole borough, which everyone can enjoy and get involved in as much or as little as they wish.
- 1.2 Every year the Events team works closely with the event organisers and key stakeholders of approximately 150 community, third sector and commercial events across our parks, open spaces and many highway locations, including street parties. The events we facilitate attract up to one million attendees over the year.
- 1.3 Many events in Lambeth need to be given approval to proceed by the Events team. We will provide the correct permits and paperwork if an event application is successful. We will also help event organisers throughout the event application process to create a safe event, advising on the appropriate infrastructure and necessary health and safety requirements, licences, legislative approvals and everything else in between.
- 1.4 This report relates purely to the 2024/25 financial year (1 April 2024 to 31 March 2025), and some issues or process details may have changed subsequently. It covers outdoor event operations only.

## 2 Governance, structure and management

- 2.1 The strategic and operational context we work to is set out in the [Lambeth Events Strategy 2020-2025](#) and the [Lambeth Events Policy 2020-2025](#). In the policy, event producers will find all the information needed to organise an event in Lambeth. We have included guidelines, suggestions, links, documents and contacts for various organisations that will help with planning an event.
- 2.2 There are four stages to the approval process for holding a public event in Lambeth. The size and scale of the event will determine the timescale and requirements needed to plan and deliver the event. The paragraphs below detail the applicable process used during 2024/25.

- 2.3 Stage One is a pre-application consultation with the team. This then leads to an official event application which allows the events officers to do a technical, operational and logistical assessment of the application. If this is approved by our event officers, the application can then be progressed to Stage Two. A considerable number of applications are rejected on receipt and do not progress to Stage One. This may be because they are inappropriate or conflict with existing applications and an alternative location or time cannot be identified.
- 2.4 At Stage Two the application information will be shared with ward councillors and the key community stakeholders identified for the area where the event is proposed to be held. This is an opportunity for the Council and event organisers to engage with key stakeholders to seek feedback or concerns regarding the event. If the concerns are addressed, the application then moves to Stage Three for the safety assessment. However, if ward councillors have particular concerns about a proposed event, they are able to trigger Stage 2A. This means that officers will invite specific key stakeholders to provide feedback on the application, allowing for a more detailed engagement.
- 2.5 At Stage Three, event officers will ensure all the relevant licences and plans have been secured for the event. This process enables the Council to have a clear set of protocols in place to ensure that our public events are safe for the public, appropriately licensed with conditions and adhere to the Council's Events Strategy, Events Policy and the specific terms of hire.

As an additional step during Stage Three, the members of the Council's Safety Advisory Group will assess the health and safety plans for more complex events. The Lambeth Events Safety Advisory Group (SAG) is made up of community safety officers from the Council and representatives who oversee public safety from the Police, Fire, Ambulance, transport for London and NHS England services. They play a key role in advising event organisers on their plans for events, raising specific objections and concerns on proposals. If the SAG raises no relevant issues of concern, then the event progresses to the fourth and final stage, where the events officers complete internal approval processes that lead to the issuing of the event permit.

- 2.6 All event applications must follow the Council's decision-making process which is outlined in the four stages within the Events Policy. At the fourth and final stage of the approval process the application decisions rested with the relevant Cabinet Member and ultimately the Director of Highways, Environment and Facilities Management, or their nominated deputy. Event organisers will be given guidance concerning this procedure by the Council's nominated events officers. If the event decision is finally approved by the Council, then the event applicant will be asked to produce confirmation of the relevant licences. If the permit is granted, then the event organiser will continue to work with and be monitored by the Council's nominated event officers to ensure the delivery of a safe and successful event.

2.7 Some events will require a more formal decision (either key or non-key). A key decision is either a major financial matter (involving income or expenditure of £500,000 or more), or a matter that has a significant impact on the community. These decision reports will be published on the Council's website.

## 3 Organisation

### 3.1 Risk Management

The events service is responsible for determining the nature and extent of the risks it is willing to take in delivering its strategic objectives.

We take into account the external and historical context that the Council may be able to control or alter and recognise there may be limited means and methods to respond. Therefore, all risks are identified at the beginning of any event proposal and assessed through a process called an event application criteria assessment matrix. This allows the event officers to identify the risks, assessing them against key objectives and working to mitigate them to an acceptable level.

All events must adhere to the Council's event application process which follows careful checks, risk assessment, adherence to controls in place; and upholding public health and safety is always a priority.

### 3.2 Lambeth Events Safety Advisory Group

The Safety Advisory Group approach was introduced nationally in direct response to the findings of the Hillsborough Inquiry which determined that communication of safety plans between event organisers and public bodies is a key component to protecting event goers. Many years later, it is inconceivable throughout the events industry that a large or complex event could or should take place without joint planning work overseen by safety professionals from the local Safety Advisory Group.

The concept of the Lambeth Safety Advisory Group (SAG) is to bring a group of service health and safety representative officers and partners together to monitor the planning and delivery of larger events. This is to ensure that any large event that takes place within Lambeth is organised and managed to the correct standard, thus ensuring the safety of both those organising the event and those attending. All public events activity in parks, open spaces and highways across Lambeth is assessed under the events policy and only approved subject to strict criteria by event officers in partnership with the SAG.

### 3.3 Audit Checks

All event applications from the very beginning of the application process are audit checked by using an audit tracking system. This has a detailed set of key tasks and milestones that must be completed and checked with the date recorded for each stage of the application in order for an event to be granted a permit. The completed Events Tracker is sent to a senior manager for final approval before a permit is issued.

This enables the event officers and managers to be assured that all processes and protocols have been followed in a clear and transparently methodical way.

## 4 Our Vision

### 4.1 Lambeth, The Perfect Place for Cultural Events

In 2019 we undertook a public consultation to review our 2016-2020 Event Strategy. Following that we established that the overarching values from 2016 should remain. But in the refreshed strategy, there needed to be a focus on events being environmentally sustainable, financially transparent, locally led and accountable.

Lambeth has a rich history of hosting a unique cultural range of arts, events and sports. Cultural events play an essential part in facilitating social awareness and cohesion.

Lambeth also has a revered legacy for the hosting of inclusive major cultural and sports events that have shaped the lives of its residents and visitors to the borough. They provide revenue to help maintain and improve our public spaces that goes way beyond the lifespan of each event.

Our events help to bring communities together, raise the profile of the borough and enrich the lives of residents through giving back opportunities for education, work and training.

## 5 Our Mission

### 5.1 The Lambeth Events Strategy 2020-2025 seeks to build on our strengths through our five mission impacts. These will look to challenge how events facilitate stronger, healthier, sustainable and cohesive communities through:

1. promoting diversity, awareness and understanding
2. leveraging investment to local communities
3. attracting creative ideas, stimulating education and knowledge
4. enriching our communities
5. encouraging business and visitor tourism.

## 6 Events facilitated

6.1 Many benefits can be realised from facilitating events, with each activity potentially benefiting different sectors of the community and local businesses. The benefits can include:

- Opportunities for young people through performance, employment and training or apprenticeships.
- Improving the availability and accessibility of entertainment and culture.
- A cultural boost to the local community.
- Development of a strong community.
- Improvements in cross community relations.
- Business opportunities both at events and in the surrounding area.
- A source of income for local projects through fundraising.
- Enhancing the image of the borough.
- Stimulating inward investment.
- Ring-fenced income for parks and open spaces.
- Bringing new audiences to the borough.

Whilst the primary benefits are set out above it is recognised that events have an economic impact, directly and indirectly creating and supporting employment. It is difficult to capture this economic impact without collecting detailed data, but a series of measures can be used to estimate the impact of events, such as:

- number of people attending
- total direct and indirect spend (including from visitors from outside the borough)
- number of full-time-equivalent (FTE) jobs involved for the duration.

### Event Operations

In 2024/25 we facilitated 148 events and 14 brand activations (162 activities in total). The 148 events were made up of 99 events in open spaces and on the highway which went through our event application process, and 49 street parties which are managed through a separate application process. The 99 standard events and 14 brand activations are all listed together in chronological order in Appendix 1.

We partly categorise events in terms of capacity on-site (including staff), and the number of events facilitated during 2024/25 by capacity are set out in the table below.

## 6.2 Commercial events

In 2024/25 there were 11 commercial events which took place in our parks and open spaces (seven per cent of the total). These offered a diverse range of activities and included Brockwell Live, Oktoberfest on the Common, Vegandale, running events, cycle rides and funfairs. The open spaces which hosted commercial events are set out in the table below.

## 6.3 Charity events

In 2024/25 there were 16 charity events in parks and open spaces (10 per cent of the total). Amongst them we welcomed the Moonwalk and the British Heart Foundation London to Brighton Bike Ride back to Clapham Common, both of which are regular fixtures in the calendar. #### 6.4 Community events

In 2024/25 there were 72 community events which took place across 20 different locations and represented 44 per cent of all events. These demonstrated the strength and diversity of the community in Lambeth, ranging from karaoke to summer programmes, remembrance congregations, free film screenings, Brixton Windmill events, summer fairs, educational activities and events bringing specific communities together. The vast majority of events taking place in our parks and open spaces are small-scale community events, with many of these being fundraising activities for parks, or free musical performances across our bandstands. The sites hosting community events are set out in the table below.

#### 6.5 Brand activation

There were 14 brand activations during 2024/25. These included distribution of free products such as carbonated drinks, pizzas, ice creams and dog treats. Brand activations were booked for Belvedere Road (1), Clapham Common (8), Emma Cons Gardens (3), Kennington Park (1) and Windrush Square (1).

## 6.6 Street parties

In 2024/25 the Events team continued to manage the process for street parties. We administered 49 free residential street parties, which took place between May and September 2024 (30 per cent of total events).

## 6.7 Social Value

There have been a range of social benefits arising from the commercial events that took place in Brockwell Park in 2024, including a free ticket ballot for local residents and the Community Fund allocations. The recipients of funding from this pot for 2024 are set out in the table below and full details can be found on the [Brockwell Live community](#) webpages.

## 7 Financial Overview

### 7.1 Events Income and Expenditure

The total income for 2024/25 generated from events in parks and open spaces was £791,856. Income from events forms part of the overall budget within the Neighbourhoods service area which includes parks and open spaces, cemeteries and tree maintenance. The total income budget for Neighbourhoods in 2024/25 was £6.773m, with the Events and Venue service accounting for 23 per cent of this. The total expenditure for Neighbourhoods in 2024/25 was £9.908m, with the Events and Venue service accounting for £736,000, or approximately 7.4 per cent of the total.

When expenditure on Venues is stripped out it can be seen that Events was a net income generating service for the authority, helping to support Parks and Tree services.

The events team primarily satisfies the high demand for small-scale community events, providing a support and regulatory service. Out of the 148 events that we facilitated, 134 (or 91 per cent) were small or medium community and charity events or street parties. The income from these events is negligible, with the service being sustained financially by a very small number of commercial events. However, the cultural value and social benefits from small community events is hugely important. The Events team ensures public safety and satisfaction and ensures events are appropriately licensed. If the Council decided to stop providing an Events service the regulatory burden for dealing with unauthorised events would have to fall elsewhere and potentially require a similar level of resourcing, but without the income generation.

## 7.2 Parks Investment Levy (PIL)

The Parks Investment Levy constitutes 25 per cent of the total income from every event. It is ring-fenced to the Parks service and does not form part of the Parks revenue budget, so can be spent on anything which benefits our open spaces. For each park, 80 per cent of the PIL generated from events there is allocated to that location, with expenditure decisions made jointly with the key stakeholder group and/or with the Cabinet Member responsible for parks. The remaining 20 per cent goes into a generic pot and is spent in smaller parks or on things which benefit all open spaces in liaison with the Cabinet Member. For 2024/25 a total of £197,964 of PIL was generated and £108,097 was spent in-year. The table below lists what this was spent on, in descending order of value. The totals generated and spent each year generally do not match due to sums carried over between financial years.

We also maintained the grant funding of up to £5,000 each to the Clapham Common, Ruskin Park and Myatt's Fields Park bandstands for a series of free to access summer concerts. The grants come from our commercial events income and the concert programmes were delivered by the Clapham Common Management Advisory Committee, Friends of Ruskin Park and Myatt's Fields Park Project respectively.
